MEMBERSHIP: Must be a current member of the USATT or affiliated ITTF Organization. USATT membership includes a sanctioned tournament rating and a bi-monthly magazine; it can be purchased through the tournament entry form.

ENTRY DEADLINE: All entries must be postmarked by 04/17/10. Entries will be limited to the first 75 players.

REGULATIONS: All USATT rules and regulations apply; only USATT approved equipment may be used.

VENUE: Hardwood floor, DHS tables, Stiga nets, Nittaku 3-star Premium 40mm Orange ball.

EVENTS: All matches will be 3 out of 5 games to 11 points.

This is a Giant Round Robin event: preliminary RR groups of 5 players, determined by USATT rating, followed by a 2nd RR of 5 players determined by the results of the 1st RR. First round table winners will play in four RR determined by rankings. The top two players from each RR will compete in a single elimination bracket to determine first through eighth places. This event is limited to the first 75 players who sign up on a first come, first serve basis. Doors open on Saturday at 8:00AM. Tournament will start at 9:00 AM. Ratings will be based on the April 2010 USATT Ratings. The tournament committee's decision is final.

DIRECTIONS: From the North--take Freeway I-5 S, then I-405 S toward Beaverton, US-26 W (Sunset Highway)

From the South, take I-5 N, and take Highway 217 exit, then US-26W (Sunset Highway). From US-26 W (Sunset Highway), take Cornell exit, turn left over the freeway, and next light turn left on 158th, turn left at the third stop lights on Schendel and proceed to the rear building (Athletic Center).
